- DOORS OPEN AT 7 A.M. ENTRIES MUST BE IN PLACE BY 9 A.M. JUDGING WILL BEGIN AT 10 A.M.
- ALL ENTRIES MUST BE BROUGHT IN COMPLETE; NO COOKING WILL TAKE PLACE ON SITE AND NO REFRIGERATION IS AVAILABLE.
- SUBMIT A COPY OF YOUR RECIPE WITH YOUR APPLICATION.
- CHOCOLATE OF SOME FORM MUST BE ONE OF THE MAIN INGREDIENTS IN EACH ENTRY.
- ENTRY MUST BE SUBMITTED FOR JUDGING ON A DISPOSABLE PLATE.
- DEPENDING ON THE NUMBER OF PARTICIPANTS, JUDGES MAY HOLD AN ELIMINATION ROUND.
- ANY PERSON WHO HAS A FAMILY MEMBER JUDGING MAY NOT ENTER.
- CONTESTANTS WILL BE ASSIGNED A NUMBER. EACH CONTESTANT SHOULD VERIFY THAT THE NUMBER ON THE SIDE OF THEIR CONTAINER IS THE SAME AS THEIR ASSIGNED CONTESTANT NUMBER.
- CHOCOLATE CREATION QUANTITY MUST CONSIST OF ENTIRE PIE, CAKE, TORTE, OR BREAD. FOR COOKIES, BROWNIES OR CANDIES, 12 PIECES MUST BE PRESENTED.
- SUBMITTED RECIPES MAY BE USED BY THE BURLINGTON AREA CHAMBER OF COMMERCE.

TASTE **10 POINTS**
(AROMA, FLAVOR, GOOD BALANCE OF FLAVORINGS)

APPEARANCE & PRESENTATION **10 POINTS**
(EVEN TEXTURE—OVERALL APPEAL)

USE OF CHOCOLATE **10 POINTS**
